Scholarship and Verification Form

High-school Merit Scholarship

East-West University offers this scholarship to outstanding high school graduates to attend any of the university's academic programs. The policies governing this scholarship are as follows:

- Amount:** \$3,000 per student for four years
Eligibility: A high school graduate with a GPA of 3.0 or better who has not attended another institution and recommended by their high school counselor.

Transfer Scholarship

East-West University offers this scholarship to students who have completed an associate degree or equivalent number of credits hours who transfer to East-West University to complete their bachelor degrees. The policies governing this scholarship are as follows:

- Amount:** \$3,000 per year for two years
Eligibility: Transfer students with a GPA of 3.0 or better with 90-quarter transferable credit hours.

Graduation Scholarship

East-West University offers this scholarship to students at EWU who will complete their bachelor degree. The policies governing this scholarship are as follows:

- Amount:** \$500
Eligibility: GPA of 2.0 or better and graduate from East-West University

Continuing Education Scholarship

East-West University offers this scholarship to prospective working adults enrolling for a degree program at the University. The policies governing this scholarship are as follows:

- Amount:** 25% tuition reduction per year until the completion of their degree as indicated at the time of registration (15% reduction for two classes, 10% reduction for one class)
Eligibility: Working adults' sponsored/supported by their organization

Shared Opportunity Scholarship

East-West University offers this scholarship to students who do not receive the ISAC grant. The policies governing this scholarship are as follows:

- Amount:** \$2,541
Eligibility: Student must maintain a quarterly and cumulative GPA of 2.0 or better and one year of continuous study

Institutional Academic Scholarship

Policy Statement

East-West University Trustees and Patrons are constantly raising funds to meet the institution's needs of development and operational improvement. The University, under specific terms and conditions, offers partial and full tuition scholarships from its own funds and from funds made available by various charitable organizations, so needy and deserving students continue studies to complete their degrees at East-West University. The University's governing body has duly adopted the policy that as a condition of any scholarship, the participating student must complete his/her degree at this University. Students who discontinue their studies without completing a degree at East-West University are subject to disqualification from the scholarship program and will be held responsible for reimbursement to the University of any funds or tuition credit received by them.

- Undergraduate and post-graduate students are required to be enrolled Full-time in undergraduate credit hours. Per federal regulations, those students who will graduate at the end of one quarter must have their loans prorated per credits enrolled.
- First-time borrowers: Entrance Counseling is required.
- Before graduating: Exit Counseling is required.
