PARTICIPANT WAIVER, RELEASE OF LIABILITY, AND ASSUMPTION OF RISK AGREEMENT

This is a legal document. Read it carefully before signing.

I, the undersigned participant (or parent/guardian if participant is under 18), hereby voluntarily agree to the following waiver and release in consideration for being permitted to participate in a sports or recreational club, open gym sessions, practices, games, team events, and all other related activities ("Activities") organized by or associated with East-West University, including but not limited to activities held at The Flats, and under the supervision of coaches, volunteers, staff, and representatives of East-West University.

1. Assumption of Risk

I acknowledge and understand that participation in sports and related activities involves inherent risks, including but not limited to:

- Physical injury (e.g., sprains, fractures, concussions)
- Illness or disease (including contagious conditions such as COVID-19)
- Emotional stress or trauma
- Property damage or loss

These risks may result from my actions, the actions or negligence of others, or the condition of facilities, equipment, or premises.

I voluntarily assume all risks, both known and unknown, associated with participation in these Activities.

2. Waiver and Release of Liability

I hereby release, waive, discharge, and hold harmless East-West University, The Flats, their respective trustees, officers, directors, employees, staff, coaches, agents, contractors, and volunteers (collectively, "Released Parties") from any and all claims, demands, liabilities, actions, or causes of action for injury, death, illness, property loss, or damage arising from or related to participation in the Activities, whether caused by negligence or otherwise.

3. Medical Consent

I authorize East-West University staff, coaches, or designated personnel to obtain medical care and treatment for me in the event of injury, accident, or illness during my participation. I understand I am solely responsible for the cost of any such medical services.

4. Insurance Responsibility

I understand that East-West University does not provide medical or accident insurance for participants in the club or sports program. I certify that I have adequate health insurance to cover any injuries or medical expenses I may incur.

5. Code of Conduct

I agree to follow all rules, instructions, and safety protocols provided by coaches, staff, or East-West University representatives. I understand that failure to do so may result in removal from the program without refund or liability.

6. Media Release

I grant East-West University permission to use photographs, video, or other media featuring my image or likeness for promotional, educational, or informational purposes, without compensation.
